

## Hospital Indemnity Insurance Benefits

With MetLife, you are being offered a comprehensive plan which provide lump sum cash payments in addition to any other payments you may receive from your medical plan. Here are just some of the covered benefits/services, when an accident or illness puts you in the hospital.<sup>1</sup>

<b>Admission</b> <sup>3</sup> must occur within 180 days after the accident	\$1,000 per accident (non-Intensive Care Unit (ICU)) \$1,000 per accident (ICU)
<b>Confinement</b> <sup>3</sup> must occur within 180 days after the accident	\$200 a day (non-ICU) for up to 31 days \$200 a day (ICU) for up to 31 days
<b>Inpatient Rehabilitation</b> stay must occur immediately following hospital confinement and must occur within 365 days of accident	\$200 a day, up to 15 days per accident but no more than 30 days per calendar year
<b>Admission</b> Payable 1 time per calendar year	\$1,000 (non-ICU) \$1,000 (ICU)
<b>Confinement</b> Paid per sickness	\$200 a day (non-ICU) for up to 31 days \$200 a day (ICU) for up to 31 days

## Benefit Payment Example

Susan wakes up in the middle of the night experiencing chest pain. An ambulance takes her to the emergency room (ER) at a local hospital. Upon arrival, the ER doctor examines Susan and advises that she requires immediate admission to the Intensive Care Unit for further evaluation and treatment. After one day in the Intensive Care Unit, Susan moves to a standard room and spends two additional days recovering in the hospital. Susan was released to her primary care physician for follow-up treatment and observation. Her primary doctor is now keeping a close watch over Susan's overall health. Depending on her health insurance, Susan's out-of-pocket costs could run into hundreds of dollars to cover expenses like insurance co-payments and deductibles. MetLife Group Hospital Indemnity Insurance payments can be used to help cover these unexpected costs or to pay for any other way expense that Susan chooses.

## Questions & Answers



**Q. Who is eligible to enroll for this Hospital Indemnity coverage?**

**A. You are eligible to enroll yourself and your eligible family members.** You need to enroll during your Enrollment Period and be actively at work or an eligible freelancer for your coverage to be effective. Dependents to be enrolled may not be subject to a medical restriction as set forth in the Certificate. Some states require the insured to have medical coverage.<sup>7</sup>

**Q. How do I pay for my Hospital Indemnity coverage?**

**A. Premiums will be paid through payroll deduction,** so you don't have to worry about writing a check or missing a payment.

**Q. What happens if my employment status changes? Can I take my coverage with me?**

**A. Yes, you can take your coverage with you.** You will need to continue to pay your premiums to keep your coverage in force. Your coverage will only end if you stop paying your premium or if your employer offers you similar coverage with a different insurance carrier.<sup>8</sup>

Hospital Confinement requires the assignment to a bed as a resident inpatient in a Hospital (including an Intensive Care Unit of a Hospital) on the advice of a Physician or confinement in an observation area within a Hospital for a period of no less than 20 continuous hours on the advice of a Physician. Please consult your certificate for details.

<sup>5</sup> The Lodging Benefit is not available in all states. It provides a benefit for a companion accompanying a covered insured while hospitalized, provided that the lodging is at least 50 miles from the insured's primary residence.
